SUBJECT: Proposed 2015-17 Small Projects

The purpose of this memo is to update and make recommendation on potential small projects proposed for 2015-17 State Capital Budget funding. We will discuss this material on our Flood Authority conference call on Thursday, October 16th. I. Background:

At the Flood Authority's 9/18/2014 regular meeting in Rochester, the Flood Authority directed staff and the Projects Committee to prepare a second-round, final list in priority order of recommended 2015-17 small projects for consideration by the Governor's Workgroup for 2015-17 State Capital Budget funding. II. Proposed and Prioritized Small Projects:

Below (starting page 3), provides for the Flood Authority's consideration and discussion a listing of potential proposed small projects in priority order that have been evaluated and prioritized on the basis of the following criteria:

- project type (1-6);
- likely ability to fully expend 2015-17 funds (Y, N, ?); and
- extent to which there may or may not be cost-benefit concerns (Y, N, ?).

Recommendation – The Projects Committee recommends that the proposed 2015-17 small project list provided here be (in its entirety) forwarded on the Governor's Workgroup (in the order and funding levels prescribed) as the Flood Authority's recommendation for further small projects funding for the 2015-17 biennium.

III. Additional Recommendation:

Through the course of the Projects Committee's work on small projects, a couple project-related topics frequently arose that the Project Committee considers warrant specific recommendation to the Governor's Workgroup.

- a. **Funding Stratification** – 2013-15 State Capital Budget contained distinct funding categories for:
- Large capital projects (\$9.2M);
 - Constructing priority local flood hazard reduction projects (\$10.742M);
 - Reducing damage to residential and other structures through elevations, buyouts, etc. (\$1.75M); and
 - Multipurpose fish and habitat projects (\$4.35M)

Recommendation:

The Projects Committee recommends the Governor's Workgroup approach 2015-17 funding through a similar set of funding categories.

- b. **O&M and Governance of Large Capital Projects** – The Projects Committee considers as one of its criteria in evaluating small projects the capacity of a project sponsor to attend to necessary operations and maintenance needs. As the Projects Committee worked through its small projects process it did discuss how it might be that governance and O&M would be addressed for large capital projects like an upper basin retention structure.

Recommendation:

The Projects Committee recommends the Governor's Workgroup approach 2015-17 funding with an intent to determine and potentially capitalize an entity to attend to longer-term O&M needs for large capital projects and projects with multi-entity benefits.

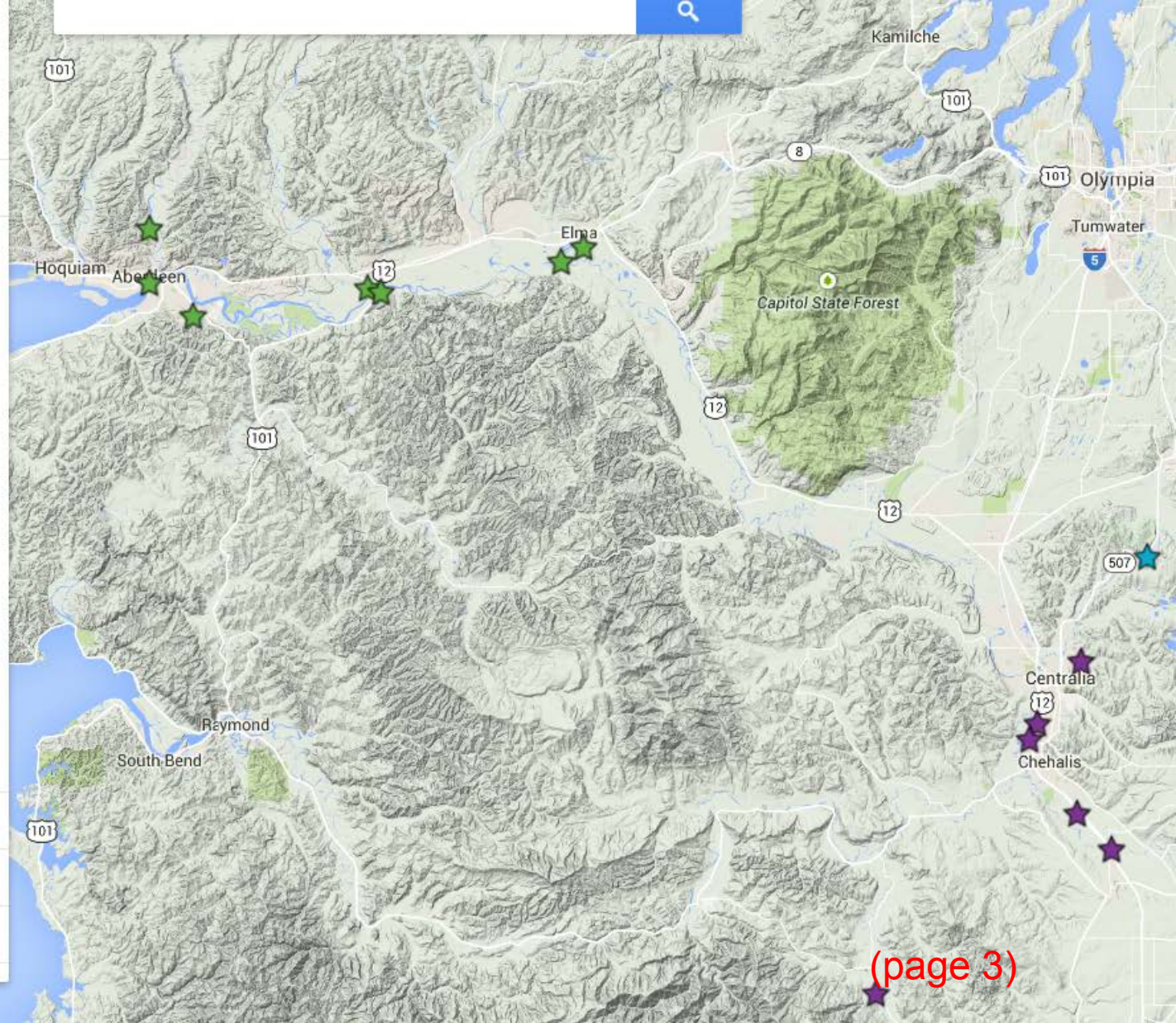
