**SUBJECT:** Change in Budget and Scope for WSCC Livestock and Equipment Pads contracts.

The purpose of this memo is to update Flood Authority members on proposed change in budget and scope for WSCC and to seek a decision on such. This will be an agenda item at our Flood Authority regular meeting this Thursday the 21st. ## I. Background

- In September 2012 \$500,000 in flood hazard reduction funding was authorized for the WA State Conservation Commission (WSCC) to design and construct Phase I Critter Pads and Evacuation Routes (now called Livestock & Equipment Pads and Evacuation Routes). OFM K1129 (10/09/2012).

- In July 2013 an additional award of funding (\$835,000) was made available to WSCC for Phase II Livestock & Equipment Pads and Evacuation Routes. OFM K1493 and 1494).

- WSCC has ~\$83,840 in unspent Phase I funds as a result using additional NRCS funds available to the WSCC. NRCS = Natural Resources Conservation Service.

## II. Proposal

- OFM and WSCC would like to clean up overall contract accounting and close WSCC's Phase I contract and transfer the excess monies to WSCC's Phase II contract. Proposal therefore is to increase the value of K1493 by ~\$83,840 (via Amendment 1) and close contract K1129.
- Additional funds in K1493 will be used to cover unforeseen costs associated with environmental review and permitting (e.g., cultural resources review, SEPA review, wetlands delineation, etc.)

## III. Decision

The decision before the Flood Authority is as follows:



Should WSCC's Phase II contract be amended by closing its Phase I contract and transferring the remaining balance of ~\$83,840 to the Phase II contract.
