

## GRAYS HARBOR COUNTY REQUEST FOR QUALIFICATIONS CONSULTING SERVICES

Grays Harbor County Department of Public Works is requesting qualifications from Consultants for the following project:

### Comprehensive Wishkah Road Flood Study M.P. 2.2 to M.P. 7.6 R-70-09889-36-00

Services may include geo-technical analysis, hydraulic analysis, flood modeling, various environmental process, preparation of technical specifications, construction cost estimate, and benefit/cost analysis as required.

The work to be performed by the Consultant consists of identifying cost effective projects to reduce/eliminate flooding of the Wishkah Road from M.P. 2.2 to M.P. 7.6. The major features to the project are:

- Review and evaluate previous studies, reports, and information.
- Study alternatives that eliminate or reduce Wishkah Road closures.
- Determine flood elevation, depth, duration and frequency for various low points of the study area.
- Determine project feasibility and adverse impacts/effects for each alternative proposal.
- Provide hydraulic modeling for each feasible alternative proposal.
- Provide benefit/cost analysis for each feasible alternative proposal.
- Identify permits required for each feasible alternative proposal.
- Identify property and easements needed for each feasible alternative proposal.
- Prepare preliminary plan and design and construction cost estimates for each alternative proposal.
- Recommend an alternative for final design.
- Provide a scope and schedule for final design and permits.

Grays Harbor County encourages disadvantaged, minority, and women-owned consultant firms to respond.

All prospective consultants are advised that EEO Compliance Review will be used on this project.

The selection of consultants for this project will include an evaluation of the following factors: key personnel, relevant experience, firm location, ability to meet schedule, past performance and in-house expertise.
