**SUBJECT:** Flood Warning System Relocations

The following Flood Warning System gage and webcam relocations will be discussed at Thursday's Flood Authority meeting. Please feel free to contact me with questions (360/480-6600, scottb@sbgh-partners.com).

## <u>Chehalis Basin Flood Warning System (www.chehalisriverflood.com)</u>

- 1. **Gage Relocations** 6 rain gages have been identified for relocation this summer (i.e., in late-June but by July 1, 2021) due to interfering excess tree growth. 5 of 6 gages have confirmed new locations. 1 gage (Newaukum) lacks a confirmed relocation site. 3 locations are under evaluation for Newaukum. New access agreements have been established with Mason County Fire District #13 and Green Diamond. Once Newaukum gage has a confirmed relocation site a new access agreement will be issued by Weyerhaeuser. See table 1.
- Webcam Relocation Due to vandalism, the Monte-Elma Bridge webcam over the Satsop river has been removed. A replacement site downstream at Chapman Farms has been determined to be a safe and suitable relocation site. Memo <a href="here">here</a> outlines recommendation to the Flood Authority to fund relocation of this webcam to Chapman Farms.
- Also -- Aberdeen Gage (Wishkah River). Technical staff at City of Aberdeen, WEST Consultants, and OneRain continue to work to bring this new gage into the Flood Warning System. Current issue is getting gage data to an Aberdeen FTP site where OneRain can pull the information down and publish to the Flood Warning System. Hopefully, this can occur in the next two months.
