

SUBJECT: 2019-21 Local Projects Recruitment Process

The purpose of this memo is to provide a brief update on the status of the 2019-21 local projects recruitment process. Feel free to contact me with questions (360/480-6600, <u>scottb@sbgh-partners.com</u>).

A. Current Status

- 2019-21 local projects recruitment document was distributed June 12, 2018 via link and website. See local projects recruitment website here → <u>https://www.ezview.wa.gov/site/alias_1492/37282/2019-21-Local-Projects-Recruitment-Process.aspx</u>.
- 2. 17 proposals were received June 3, 2018. All proposals were received on-time with no proposals being received late.
 - All 2019-21 local project requests tally to \$10.2M (with \$7.8M for Construction and \$2.4M for Plans/Studies).

B. Next Steps

2019-21 Local Projects Process:

- 1. July 26, 2018 -- 2019-21 Local Projects Reviewers Group will meet to review and evaluate project proposals.
- 2. September 6, 2018 -- Chehalis Basin Board reviews/discusses INITIAL DRAFT LIST of ranked/prioritized local projects.
- 3. September 20, 2018 -- Flood Authority reviews/discusses DRAFT LIST of ranked/prioritized local projects.
- 4. October 4, 2018 -- Chehalis Basin Board reviews/discusses PROPOSED FINAL LIST of ranked/prioritized local projects.
- 5. October 18, 2018 (SPECIAL MEETING) -- Flood Authority reviews/discusses/recommends FINAL LIST of ranked/prioritized local projects.

Local Projects (Chehalis Basin Board):

At July 12, 2018 Chehalis Basin Board meeting, the Board discussed updating an animated PPT that is being prepared re the Chehalis Basin Strategy with the following local projects information:

- 1. Single map showing completed, in-progress, and proposed projects for the period 2012 to present with legend showing \$\$\$ appropriated to date for local projects (to be updated with 2019-21 \$\$\$ request).
- 2. A handful of photos representing the typical kinds of local projects funded.

- 3. The total \$\$\$ invested to date for local projects (through the Flood Authority, state Chehalis Basin Strategy, and including any local/federal match).
- 4. A bulleted list showing name and location of each local project funded to date.
