8. I-90 Capacity - STEER I-90 Coalition Update

Mark Cook, Kittitas County

- Mark – provided information about sponsoring initial funds for widening I-90 to get it on the State Transportation Improvement Plan. He mentioned working with federal lobbyist, The Ferguson Group. Kittitas County will update the STIP by amendment in January to include the initial I-90 project phase. TFG host monthly stakeholder meeting. Starting in January speakers will be invited to speak about issues such as freight, habitat, economics, and emergency response for feasibility study. To date Kittitas County has spent funds to conduct speed/volume studies and attempted to implement traffic calming efforts. Nicole can distribute STEER I-90 information if people would like.

9. Regional WSDOT Planning Offices and Headquarters Updates

WSDOT Region Representatives

- WSDOT Region Updates
- Kate Tollefson WSDOT Stated she is excited for RTPO coordination with HSTP update work.
- Paul Gonseth Spoke to I-90 projects to move forward
 - Phase 3 Easton Hill new lanes towards Cabin Creek.
 - Snoqualmie is experiencing same issues as Kittitas County. Having conversations with their representatives about I-90 issues.
- Max Nelson NC Region Project updates.
 - Grape Drive roundabout is on schedule.
 - The region is experiencing staffing shortage in maintenance with signage crews
 - Two paving projects include SR 17 and chip seal south of Moses Lake.
 - Updates to be happening to variable messaging signs in Vantage area.
- George Mazur NC Region Project updates.
 - Planning initial work items on SR 28, CDTC conducting a study for 4 lanes between East Wenatchee and Rock Island as well as preparing a cost estimate for 4 lanes for Rock Island to Quincy. Market assessment to be conducted between Rock Island and Quincy. Mid 2022 third phase would include developing an implementation plan. Most work done in Douglas County, but it might cross into Grant County. Discussions with Grant County would occur prior.
- Charlene Kay WSDOT Multimodal crossing projects.
 - Studies are adjacent to Davenport US 2 and West Plains from air force base to I90 and downtown. Phase 2- West Plains in and around I-90 – Medical Lake interchange.
 - TSMO study along I90 ramp meters.
- Pete Martin Working toward some clarification and guidance on bipartisan infrastructure law. Staff will have FHWA site up for information.
- Mark Cook Question for companion counties: The termination of WSDCOT maintenance crews from Bullfrog has spurred Kittitas County mutual aid agreement with WSDOT for snowplowing. Has anyone else been contacted to assist with winter maintenance? Adams County (Todd O'Brien) has not been contacted but has heard rumor and Adams County is planning to reshuffle staff/equipment to aid in arterial roads. Cost recovery is possible from WSDOT possibly.
