Planning projects submitted from the new project call were vetted for eligibility and the project that met the eligibility criteria was sent to the selection committee for ranking. The committee unanimously voted to recommend move the Othello project forward to QuadCo Council for inclusion in the UPWP SFY 2019-2021 planning project. A total of \$46,300 unallocated funds was available for the new project call. With project approval, \$28,300 will remain unallocated.

#### 6. 4-COUNTY HSTP PLANNING COMMITTEE

Jan Ollivier provided an update of recent HSTP Planning Committee Meetings. She stated the committee is working to determine roles and responsibilities of the committee and are close to finishing. She noted that questions have arose during this process: membership and who should vote, what is a quorum and who should be appointed from QuadCo and how that position would be handled.

O'Brien added that in looking through previous files from QuadCo meetings and committee meetings, it appears there is no paperwork identifying the members of

the committee as well as the roles and responsibilities. O'Brien recommended that Lead Agency work with the sub-committee utilizing work the sub-committee has already completed, with the recommendation vetted through WSDOT, and return to the next QuadCo Council meeting with a recommendation to formalize what this committee consists of, who/what organization is a voting member of the committee and roles and responsibilities. It was suggested that a committee charter be formed and added to QuadCo's bylaws. The group agreed by consensus.

#### 7. LEAD AGENCY UPDATE

Todd O'Brien

It was noted that Lead Agency attended the Practical Solutions Workshop on Aug. 22 at the WSDOT South Central Region and the Coordinating Committee Meeting on Aug. 27 at the Spokane Regional Transportation Commission Office. Items from the meetings include discussion about messaging of maintenance and preservation, especially if there is another state transportation package.

WSDOT's Highway Systems Plan was also discussed at the Spokane meeting. It was noted that the plan hasn't been completed for 12 years, and that RTPOs and MPOs (Metropolitan Planning Organization) were asked for input.

In addition, HB 1584 was discussed at the Spokane meeting. According to the bill, "[A] regional transportation planning organization must provide a reasonable opportunity for voting membership to federally recognized tribes that hold reservation or trust lands within the planning area of the [RTPO]. Any federally recognized tribe that holds reservation or trust land within the planning area of a [RTPO] and does not have voting membership in the [RTPO] must be offered voting membership in the [RTPO] every two years or when the composition of the board of the [RTPO] is modified in an interlocal agreement."

WSDOT HQ will audit within the next two years to ensure tribal inclusion in RTPOs.

The bill took effect on Aug. 1, 2019. Member agencies were asked to provide a list of federally recognized tribes in their area with contact information to Lead Agency.

# 8. REGIONAL WSDOT PLANNING OFFICES AND HEADQUARTERS UPDATES WSDOT Region Representatives

Project updates provided by WSDOT representatives.

Dale Pomeroy inquired about possible work on SR-17 at Warden. Traffic count and the high rate of accidents were noted. In addition, it was noted that funding statewide is based on reports from WSP.
