A letter was received from the City of Moses Lake by Lead Agency in August withdrawing the project.

The Town of Reardan reported that a request for proposals was issued and they are waiting for selection to begin preliminary engineering. They expect to begin work the first part of 2021.

Lead Agency discussed what the de-obligation of funding for the Ephrata and Moses Lake projects would mean for available funding. In current year 2021, a total of \$595,365 would be available to allocate. It was discussed that Reardan's original request was for \$227,309 and that \$375,477 was submitted for federal prospectus with a 13.5% local match. The Town of Reardan submitted a request for full funding to Lead Agency for \$434,017. It was also noted that there are no other projects identified for funding other than Reardan.

The City of Ritzville representative made a motion to fund the Town of Reardan's project at 100% for a total of \$434,017. Grant County representative seconded the motion. Motion passed unanimously by poll.

5. FEDERAL PROGRAM TARGET DELIVERY & STBG SET-ASIDE PROGRAM CALL FOR PROJECTS 2021

The council agreed by consensus to have Lead Agency prepare for a call for new projects at the next meeting. It was noted that the projects need to be shovel ready, viable projects that can expend the allocation within the given time period. In addition, projects would be ranked and voted on at the May 2021 meeting.

6. 4-COUNTY HST PLANNING COMMITTEE UPDATE

Jan Ollivier provided information and an update on the 2021-2023 Consolidated Grant Program, in which funding is available for operating, purchasing equipment, capital purchases and mobility positions. Grant applications have been submitted to the state, and all applications need to be sent to Lead Agency. Lead Agency will refer applications to the 4-County HST Planning Committee for review and ranking. Quadco Council will approve the ranking before submitting it to the state by Feb. 26, 2021.

In addition, Ollivier provided a brief update of the committee's role and current work.

A volunteer was requested to serve on the committee as a representative of Quadco. Keith Elefson, Grant County, volunteered.

The City of Ellensburg representative made a motion to approve Keith Elefson as a Quadco Representative. Lincoln County representative seconded the motion. Motion passed unanimously by poll.
