Leadership Group Recommendations:

- Continue to strengthen support for state and local government involvement
- Work to better explain recreational benefits of Integrated Plan
- Articulate the connections between tribal, federal, state and local governments funding this work
 - Increase this in our messaging, documents and handouts
 - Tell the private funding story as well
- Share timelines that identify out-year funding needs
- Tell the human side of the fishery and water supply story
 - Values, livelihoods, hopes for the future
- Emphasize the existing conservation work, to better illustrate that we cannot 'conserve our way out' alone





Water Conservation and Efficiencies



USDA has committed \$40 million to water conservation and efficiency projects.

Partnering with NRCS, EQUIP and Reclamation's WaterSMART to maximize investment benefits.



YRBWEP conservation projects currently save 69,000 acre feet annually, with 128,000 identified under potential future projects. The YBIP has identified 170,000 additional acre feet.

Total savings: 297,000 acre feet per year



Roza Irrigation District has spent ~\$36 million to conserve 39,500 acre feet since 1983. Ron VanGundy described the canal lining, sealing, automation and on-farm efficiency projects, prompted by the Clean Water Act.

NRCS Regional Conservation Partnership provides technical assistance and funding to operational improvements like those enacted by the Yakama Nation.

Washington leads the nation in RCPP grant funding



New Commitments

- NRCS reaffirmed commitment to State agencies
- General commitment of support from national level into the new administration
- Counties committed to fulfilling responsibility to demonstrate whether water is legally and physically available for development
- Partnerships between DOI, NRCS, Reclamation to grow and refine funding strategies for on-farm and system improvements
- The Integrated Plan will be highlighted for White House leaders in USDA's December National Drought Resiliency Plan report

The DC Leadership Group will:


- Implement changes to charter
