



### **Group Responses**

- S.C. will decide but if they ask:
  - All felt we had done the "heavy lifting" and were just polishing our recommendations so not necessary from our point of view
  - Decided it would be easier to put subsequent language for updated methodology into Motion instead of language requiring the ICT to control updating a master document/rule
  - Many felt that a guidance document for additional cannabis related changes/additions to EPA methods would be a good way to move forward with 1 member saying to be cautious not to put "Rule Level" things into a document
