From Bacteria and Temperature Workgroup Meetings on October 16, 2018

The East Fork Lewis River Partnership Bacteria and Temperature Workgroups met on October 16, 2018, at the Washington Department of Fish and Wildlife. The purpose of these meetings was to learn more about implementation efforts underway in the East Fork Lewis River Watershed, Clark County, and Southwest Washington; to start identifying critical areas and priority implementation actions; and discuss opportunities to address water quality impairments in the watershed.

  - Lower Columbia Fish Recovery Board provided an update on long-term efforts to improve water quality in the region.
