# **Minutes**

#### I. New Business

#### A. Upcoming Case Preview

- 1. Geoff provided updates for the following cases:
  - Coleman Oil, August 1, 2018, tanker truck gasoline spill into the Duwamish Waterway
  - Achilles USA, July 27, 2018, oil spill into a retention pond
  - P/C Panacea, July 8, 2018, fire and sinking into Lake Washington

### **II. Old Business**

#### A. Open RDA Case Updates

- 1. Sulphur Creek, March 1, 2015 spill into the Yakima River
  - Geoff: Still waiting to hear from Ward regarding the exact location of the property. My
    intention is to assess the ecological value of the area and discuss project options.
  - Don: Had a discussion with his contact in the National Pollution Fund Center. They
    appear open to the idea of bringing this case to them as a natural resource damage
    claim.
- 2. F/V Privateer, April 15, 2016 spill into the Pacific Ocean
  - Geoff: Larry Altenbrun sent a follow-up e-mail to clarify the language in his June 26, 2018, letter. This added language brings the proposal in line with the conditions set forth by the RDA committee when the project was approved at the June meeting.
  - Jessica: State Parks is meeting with Larry Altenbrun to talk about the specifics of property acquisition and payment.
  - Geoff: Working on draft MOA for this agreement. Will submit first draft by the end of the week.
- 3. Tug Island Wind, February 28, 2017 spill into Elliot Bay
  - Geoff: Spoke to Erik at Island Tug and Barge (ITB) and discussed the logistics of using their equipment for a marine debris removal project. ITB would need assistance from a salvage company to gather the debris. For large debris removal projects, DNR usually hires Global Diving and Salvage who sub-contracts a tug and barge. ITB has worked with Global in the past. Geoff will reach out to Global to discuss this project idea.

- 4. Coleman Oil, March 18, 2017 spill into the Columbia River
  - Geoff: Spoke to Valerie with TCP. She is open to the idea of pursuing a joint NRDA with the Spills program. She is also open to the idea of accepting a restoration project in lieu of a damage claim payment that will satisfy both program RDA's.

# PREASSESSMENT SCREENING OIL SPILL REPORT FORM

Date of Incident: July 8, 2018

Potentially Liable Party: Rod Johnson

Product Spilled: Diesel fuel

Spill Source: M/V Panaeca

Oil Spill Size Estimate: 160 gallons

Water Body Affected: Lake Washington

**Ecology Region: NWRO**

Location of Spill: 20' offshore of Saint Edward State Park (approximately 47.73864, -122.27072)

Cause: Structural Failure, Fire

**Ecology Responder:** Trevor Braund

Field Report: Northshore Fire Department put out a fire on the 40′ M/V Panaeca and began towing the vessel to the Kenmore boat launch when it sank and began to spill fuel less than 100′ offshore of Saint Edwards State Park. Responders did not initially boom the vessel due to concern that the spilled fuel was gasoline. Once contact was established with the vessel owner, they informed Ecology that there was approximately 350 gallons of diesel fuel aboard at the time of the fire. The King County Sheriff Marine Unit, Ecology and EPA placed boom around the vessel once the fuel type was discovered. Global Diving and Salvage removed the remaining fuel, recovering about 140 gallons. St. Edwards State Park was notified of the spill, and they posted a "no swimming" advisory for park visitors. An estimated 160 gallons of diesel fuel spilled to the lake. On July 24, Northern Marine Construction used a crane barge to salvage the vessel.

Field Report: Ecology was notified of two completely oiled Canada geese were brought into PAWS. They were collected in the general vicinity of the Narbeck Wetland Refuge in Everett. By day 2, responders discovered an oiled retention pond at the Achilles USA plastic sheeting facility. Achilles staff said that they recently had a 100 gallon lube oil spill to their storm system, which leads to the pond. The pond is heavily vegetated, has been stocked with fish, and is providing habitat functions for a number of bird species. Achilles hired Clean Harbors to clean-up the oil, and Focus Wildlife to rescue the oiled birds. A number of oiled waterfowl been observed, and some have been captured and cleaned. The birds will be released once cleanup is complete.

**County**: Snohomish

**Nearest City**: Everett

Location of Spill: Peacock Landing Marina, 6300 12th SE

Cause: Vessel sank

Ecology Responder: James Zuluaga

**Field Report**: The vessel sank at the dock due to hull damage caused by large woody debris coming down the slough after very heavy rains. High wind, currents, and rain prevented divers from even getting in the water for 12 days. During this time, a constant stream of oil drops were seen coming off the vessel. When conditions improved, Global Diving dove on the vessel and found that the fuel tanks were empty. The owner thought that there was less than 100 gallons on board prior to it sinking.
