Geoff is working with the Deatons' to set up a site visit to this property for WA ECY, WDFW, and the Yakama Nation. A decision will be made following this site visit what process will be used for RDA.

# 2. P/C Wild at Heart, November 14, 2015 sinking and spill into Ebey Slough

- Alison: WA AG's office has been able to obtain additional information regarding the assets of the RP for the P/C Wild at Heart incident. The RDA claim for this incident has not been paid, but WA AG's office could potentially put a lien on the RP's property.
- Vote: 6 yes. Geoff will follow-up with the WA AG's office about pursuing putting a lien on the RP's property.

## 3. F/V Privateer, April 15, 2016 spill into the Pacific Ocean

- Alison: MOA for this incident has been signed by all three parties, WA ECY, the RP, and WA State Parks. Geoff with send out an announcement with all the specifics.
- 4. Tug Island Wind, February 28, 2017 spill into Elliot Bay
  - Alison: No update.

#### 5. Coleman Oil, March 18, 2017 spill into the Columbia River

- Alison: Prior to the RDA Meeting, Geoff spoke briefly with Allyson Bazan about the
  possibility of combining Spills and TCPs RDA actions. From that conversation it was
  determined that additional discussions are needed to decide if two RDA actions can
  be combined.
