# What Ecology is up to

#### Washington State Recycling Steering Committee

Held initial Washington State Recycling Steering Committee meeting – did introductions and talked about purpose and goals.



Working on hiring a third party facilitator for the process.

#### Research

- Will not be partnering with DEQ for research projects due to the length of time necessary to negotiate intergovernmental agreements.
- Will continue to coordinate while doing some research separately

### Outreach campaign

- Currently putting together a request for proposal
- Focused on reducing contamination and waste prevention
- Hopefully get this together in the next few months

## Julie Robertson – Legislative update

- Putting together the revenue package for our Agency
- Draft legislation that would include a recycling development center and state and local contamination reduction and outreach plans
  - Local plans will address contamination and be able to use a state plan as guidance
  - Should have draft legislation in the next few weeks for review- will send to the group

#### Comments - what are other people working on?

Nina Goodrich - Sustainable Packaging Coalition

- WRAP Wondering if people would be interested in plastic bags and film programs
- Need to ensure that they have buyers, especially local opportunities (perhaps work with local colleges to see if they could develop programs on this)

#### Lisa Sepanski – King County

- King County is interested in getting involved in the WRAP program, have been trying to get a similar program going for awhile
- Question: Wondering about the scope of work development for research between DEQ and Ecology
- Alli: Oregon has the lead on this and will find out what they will be moving forward

#### Polagaya McLaughlin – Snohomish County

- Question: Wondering if people are having trouble with metal markets? Troy Launtenbach: Schnitzer reports that the prices for ferrous and non-ferrous are dropping
- Comments on changes in pricing:
  - Price of cardboard is dropping
  - o Paper is zero
  - No plastics
  - Paying for glass

#### Scott Farling - Titus MRF Services

• Taking some mixed plastics to LA and will provide an update

#### Gene Clack – Island County:

- Changing recycling program (today 8/15/18), dropping plastics except #1 and 2
- Messaging about changes in recycling market conditions/Chinese ban on recycling

Question: What's happening in the rest of the country?



Rest of country is not as impacted as the west coast, as there are more markets developed in other parts of the country. The Southeast is not feeling as much pain, due to localized markets. Reports indicate that Vermont is having trouble with paper and Colorado starting to be impacted
