Draft manual with redlines was provided by Weblink from Ecology to SAM Source ID group on 1/21/20. A Comment Log was used by reviewers to make comments/suggested edits to the draft. Reviewers included: King County Stormwater Services; King County Environmental Lab; City of Vancouver, WA; City of Seattle; City of Shoreline; City of Deliverable Kirkland. Draft manual suggested edits were discussed by King County, Herrera and Aspect on 3/5/20. Draft manual

okayed to proceed to final production on 3/5/20. Final Manual provided to King County on 5/18/20; King County okayed final manual format and forwarded final manual to Ecology on 5/19/20. Ecology requested one minor wording change, which Aspect did. This 'final final' version was routed to Washington Stormwater Center and Ecology, for posting on websites. King County's Stormwater Services website has a link to Washington Stormwater Center's website.

Description of your Achievements: Worked with Consultant on portions of the draft and final manual, including reviewing, commenting, and researching.

Task 3A: Disseminate manual updates to permitees and announce trainings

Percent of Task Completed: 50%

Deliverable 8 not fully completed yet in that trainings could not be announced in Jan-June 2020 as they had been cancelled due to COVID-19 and had not been re-scheduled yet. However, the flyer announcing manual updates and Deliverable how to sign up for trainings (when they will be held) was drafted on 3/16/20, sent for review by Ecology and King County on 3/17/20, and finalized/sent to Ecology and King County on 6/25/2020. Additionally, the following tasks supporting Del. 8 were completed as follows: Aspect's James Packman presented to the Stormwater Work Group the manual updates on 6/3/20; this meeting was attended by King County and Herrera staff.

3. Tasks/Milestones not achieved and why:

The originally planned 'live, in-person' workshops on using the manual were not held due to their cancellation by COVID-19 pandemic cautionary measures.

4. Potential Future Challenges to Performance (time delays, staff changes, etc.):

If the contract amendment (see No. 5 below) is approved, the contract is expected to be completed by its proposed new contract extension deadline of 1/31/20.

5. General Comments:

Because of COVID-19 pandemic measures, the workshops planned for the spring and early summer of 2020 could not be held in person and were cancelled. Due to this reality, the consultants had to re-format the workshops to be compatible with a 'virtual' environment. All 'virtual' workshops will be rescheduled in late summer 2020, and hopefully will be held in autumn/winter 2020. Related to this, King County is requesting from Ecology a contract amendment to extend the deadline of the contract from 8/31/2020 to 1/31/2021. Jeanne Dorn submitted an extension request to Brandi Lubliner of Ecology on 7/22/2020. Due to the unforeseen, unpredicted extra time and effort imposed on the contract by the pandemic measures, additional money has been requested of Ecology so that tasks and deliverables can be completed by 1/31/2021.

6. List the cumulative totals for all "outputs" (numerically measurable accomplishments) under this contract to date:
