Planned actions for the next two quarters

Upland Finfish General Permit: The Upland Finfish General Permit was out for public review and comment from April 7, 2021 until May 26, 2021. A permit reissuance decision is anticipated in fall of 2021. Boatyard General Permit: The Boatyard General Permit was out for public review and comment from March 3, 2021 through April 16, 2021. In order to ensure that we have the time to review comments and be responsive we have delayed the reissuance schedule for this permit. We anticipate that this permit will be expired for a few months prior to a reissuance decision. A permit reissuance decision is anticipated in fall 2021.
