NPDES and State Waste General Permit scheduled actions in 2021-2022. The months below are approximate.

Planned actions

Boatyard General Permit¹: The Boatyard General Permit was out for public review and comment from March 3, 2021 through April 16, 2021.

In order to ensure that we have the time to review comments and be responsive we have delayed the reissuance schedule for this permit. We anticipate that this permit will be expired for a few months prior to a reissuance decision. A permit reissuance decision is anticipated in early spring of 2022. <u>CAFO General Permits</u>²: We began this reissuance process with informal listening sessions in January 2021. In June 2021, the Washington State Court of Appeals issued their <u>decision on the CAFO General Permit appeal</u>³. The court affirmed in part and reversed in part the October 2018 decision by the Pollution Control Hearings Board (<u>PCHB case no. P17-016c</u>⁴). The permits are remanded to Ecology for rewriting consistent with the court's opinion. Because the court's decision required significant changes, we have revised our reissuance schedule and will hold a second round of public listening sessions in fall 2021. These listening sessions will be held October 12th and 14th of 2021. We anticipate that this permit will be expired for approximately nine months prior to reissuance. Fresh Fruit Packing General Permit⁵: A draft of this permit is currently out for public review and comment. Ecology is accepting comments on this draft permit from Sept. 1, 2021 until Oct. 15, 2021, at 11:59 p.m. You may submit comments through the online comments form⁶. Workshops and public hearings are scheduled for October 6th and 7th. A permit reissuance decision is anticipated in the fall of 2021. Irrigation System Aquatic Weed Control General Permit⁷: We hosted two online public listening sessions on Aug. 10, 2021, and Aug. 12, 2021. We are planning on issuing a formal public draft for review and comment in winter 2021. Workshops and public hearings on the draft permit are projected to be held in early 2022. Phase I Municipal Stormwater General Permit Modification⁷: Phase I municipalities were required to adopt a stormwater program that provides equal or greater protection of receiving waters and pollutant control as compared to the 2019 Stormwater Management Manual of Western Washington. We decided that the stormwater programs submitted by the Phase I permittees are equivalent and are seeking to modify the permit based upon our decision. The public comment period ran from July 21, 2021 until 11:59 p.m. on Aug. 27, 2021 and two public workshops and hearings were held on August 24th. Proposed Puget Sound Nutrient General Permit⁸: Public comment on this draft permit ran from June 16th through August 16th of 2021. Ecology is in the process of reviewing the comments received, making changes to the draft permit, and developing a formal response to all comments received.
