**Community Based Organizations**  Middle Housing Grant Requirement Community Based Organizations

(ii) Subcontract with multiple community-based organizations that represent different vulnerable populations in overburdened communities, as defined in RCW 70A.02.010, that have traditionally been disparately impacted by planning and zoning policies and practices, to engage in eligible activities as described in (b) of this subsection.

Middle Housing Grant Requirement (cont.) Community Based Organizations

(b) Grant recipients must use grant funding for costs to conduct at least three of the following activities:

(iii) Conducting outreach, including with the assistance of community-based organizations, to inform and solicit feedback from a representative group of renters and owneroccupied households in residential neighborhoods, and from for-profit and nonprofit residential developers;

#### Environmental Justice RCW 70A.02.010

(14)(a) "Vulnerable populations" means population groups that are more likely to be at higher risk for poor health outcomes in response to environmental harms...."

(b) "Vulnerable populations" includes, but is not limited to:

- (i) Racial or ethnic minorities;
- (ii) Low-income populations;

(iii) Populations disproportionately impacted by environmental harms; and

(iv) Populations of workers experiencing environmental harms.

### Community Based Organizations

- Benefits
  - People feel more comfortable engaging through a familiar organization
  - Access those with more direct lived experience
  - Long term relationship building/partnership
  - May be familiar with other organizations or groups to conduct outreach
- Use of Funds
  - To be used by the CBO, not the grantee
  - Common CBO use of funds might be translation services, events, informational materials, meeting expenses (facility rental), child care, adult care, travel
  - Approx. \$2,000 per CBO

## Racial Equity Work

#### Racial Equity Analysis Work Data and Lived Experience

Draft Racially Disparate Impact (RDI) guidance speaks to data and community engagement informing one another

#### DATA

- Use a variety of data sources and approaches, assess current housing patterns to determine if there are racially disparate impacts, displacement and exclusion in housing
- Analysis should provide information on the nature, degree and related factors of disparate impacts as well as identify areas at higher displacement risk

#### RDI Evaluation Methodology: Policy and Regulation Evaluation

**Understand your community:** Identify measures to evaluate racially disparate impacts, exclusion and displacement and populations at risk

Analyze data: Examine data for racially disparate impacts, exclusion and displacement and identify areas of higher displacement risk

Community engagement throughout **Evaluate policy:** What policies contribute to disparate impacts, displacement or exclusion?

**Revise policy:** What new or improved policies are needed to undo impacts? Prevent displacement?

**Review and revise regulations:** What regulations and programs are needed to address and undo impacts?

- Rate of more than one occupant per room
- Housing tenure by race






Predominant race/ethnicity


Racial segregation according to the Theil Index, 2010.

#### Estimated median income



- Foreclosures (here: properties subject to foreclosure)
- Evictions
- Tenant relocation applications
- Expiring affordable housing covenants
- Condemnations
- Units lose to natural disaster or eminent domain
- Deterioration in housing quality



### Areas at Risk of Displacement


- Create your own analysis using:
