Mayor Pro-Tem: Holyk: Who is licensed to do these septic inspections? Paul Tester, Public Works Supervisor: Pete has a license & can do this for the Town. Mayor: The workshop is good & if everyone's schedules are cleared for August 11th.. Meeting will be at 7:00 PM in Council Chambers. All agreed & meeting is set.

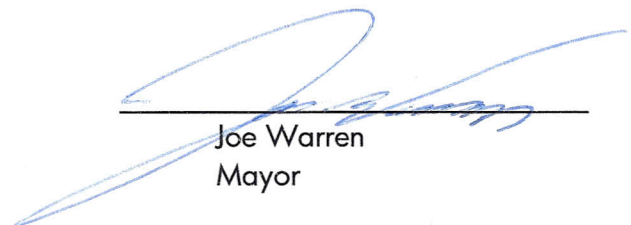
