DETERMINATION OF NONSIGNIFICANCE (DNS)

Action:

A non-project action SEPA for the City of Hoquiam Shoreline Master Program (SMP) 2016 Update

Description of Proposal:

In 2003, the Washington State Department of Ecology adopted new Shoreline Master Program (SMP) guidelines to emphasize ecologically appropriate development. As a result, Hoquiam's Shoreline Master Program, which was initially adopted in 1976 and last amended in 1987, was updated. The City is completing the update process to complete the SMP revisions and ensure consistency with the State master program guidelines.

The City's SMP update carries out the policies of the Shoreline Management Act (SMA) at the local level, regulating new development and use of shorelines. Master programs are defined in the Shoreline Management Act as "...the comprehensive use plan for a described area, and the use regulations together with maps, diagrams, charts, or other descriptive material and text, a statement of desired goals, and standards developed in accordance with the policies enunciated in RCW 90.358.020." A shoreline master program is essentially a comprehensive plan and zoning ordinance with a distinct environmental focus applicable to shoreline areas tailored to local circumstances.

Once adopted, the updated SMP document will regulate development within the City's Shoreline Jurisdiction.



An environmental impact statement (EIS) is not required under RCW 43.21 C.030 (2)(c). This decision was made after review of a completed environmental checklist and other information on file with the lead agency. This information is available to the public on request. This DNS is issued under WAC 197-11-340(2); the lead agency will not act on these proposals for 14 days from the date of publication, allowing time for public comment.

Comments on the Threshold Determination: If you would like to comment on this Threshold Determination, comments must be sent by June 9, 2016, at 5:00 pm to 609 8th Street, Hoquiam WA 98550, Attn: Brian Shay, City Administrator. The City will not take final action on this proposal until after the end of the comment period.

The issuance of this DNS should not be interpreted as acceptance or approval of this proposal as presented. The City of Hoquiam reserved the right to deny or approve said proposal subject to conditions if it is determined to be in the best interest of the City and / or necessary for the general health, safety, and welfare of the public.

Appeals: This DNS may be appealed. The City of Hoquiam adopted WAC 197-11-680 by reference. Any agency or person wanting to appeal the City's procedural compliance with WAC Chapter 197-11 for issuance of the final DNS and substantive determination on the action must file its appeal to the Hoquiam City Council within 10 days of the end of the comment period. Appeals must be delivered by June 19, 2016, at 5:00 pm to 609 8th Street, Hoquiam WA 98550, Attn: Hoquiam City Administrator.
