their habitats for the benefit of future generations - a mission we can only accomplish in partnership with local governments.

WDFW would like to take this opportunity to recognize the improvements we found in the Adams County SMP proposed amendments, including:

- Article II, Section 18.08.200, Page 12 – The adoption of the definition for ‘Fish and Wildlife Habitat Conservation Areas’ as found in RCW 36.70A.030.
- Article II, Section 18.08.200, Page 18 – The recognition of Priority Species and that, “The state Department of Fish and Wildlife maintains the most current listings and should be consulted as necessary for current listing status.”
WDFW’s PHS Program is a source of best available science and provides a current PHS List, Map and Management Recommendations as resources for local jurisdictions.

WDFW also supports Adams County’s current buffer width requirements in the vicinity of streams and lakes in shoreline designated areas, found on Page 63 in Table 18.08.650-1 – Shoreline Management Buffers. The buffer width requirements are consistent with WDFW’s Priority Habitats and Species (PHS) publications on riparian ecosystems, focusing on the needs of fish and other aquatic wildlife (PHS Riparian Ecosystems, Volume 1: Science Synthesis and Management Implications
